Funding is limited, especially for overnight camp, and applications may take up to three weeks to process so call today!

Step 1: Choose a camp that appeals to your child. Unless there is a special circumstance, choose a camp located in Muskoka.

Step 2: Complete the attached **Summer Camp Funding Application Form**. If you have more than one child, please complete a separate application form for each child. You can copy this form or call the phone number listed on the back of this brochure for more copies.

Step 3: If you are in receipt of Ontario Works or Child Care Fee Subsidy, complete and return this form to your Case Manager.

For all other applications, **please attach a recent Notice of Assessment for each parent in the home** and return it to the Children's Programs team listed on the back of this brochure.

For those who qualify for funding, the District of Muskoka will pay the cost of camp directly to the Summer Camp listed on this application form. A maximum allowance per camper applies.
